Official Match Program:

This document serves as the official match program for the 2021 American Smallbore Shooting Association National Championships. Competitors are to familiarize themselves with the program and the changes which have been incorporated from last year.

COVID-19 Protocols:

ASSA will continuously monitor federal, state and local updates on COVID-19 protocols and provide notifications as it applies to conducting the match.

In order to provide a safe environment, ASSA will be implementing a COVID-19 plan that includes registration, social distancing, mask utilization, cleaning & sanitation activities, etc. This plan will be based on the most current information available and will apply to anyone attending or participating (staff members, competitors and coaches) any of the championship events.

All parties who plan to attend are also reminded to conduct daily personal screening to ensure the safety of others. If you experience any symptoms of COVID-19, do not come to the competition and self-quarantine per CDC guidelines.

ASSA is actively working to conduct a safe and enjoyable national championship, however there is always a possibility that major modifications to the match, up to and including cancellation, may be necessary based on the current COVID-19 situation so your patience is sincerely appreciated.

Additional Events:

In addition to the 3-position, F-Class and conventional prone matches, the American Smallbore Shooting Association (ASSA) is also working with The St Joseph Valley Rifle & Pistol Association to organize additional events and functions, which are all PENDING at this time.

Match Entry:

Entries will be accepted up to the following date: June 25, 2021. After this date, entries will be available at the range (up to range capacity) subject to an additional \$25 service charge.

****NEW FOR 2021**:** Team entries are now able to be conducted online via the ASSA website. This will further improve and streamline the check in and final registration process at the range. By conducting online team entries, this will also minimize direct social interaction per government COVID-19 recommendations.

Confirmation of registration will be sent via email.

Entries received by June 18, 2021 that include the competitor's shirt size will receive a championship t-shirt upon completion of check in at the range. Entries received after this date would only receive a t-shirt pending remaining availability at time of check in and requested size will not be guaranteed.

Entries Using ASSA Discount Entry Waivers:

Competitors who are using ASSA National Championship discount waivers for 1/2 off entry fees can pay the balance of their entry via one (1) of two (2) methods:

- Enter on-line and submit full payment for the phase(s). ASSA will issue their rebate via check upon completion of their final registration at the range.
- Submit their entry via USPS by sending their entry form, waiver (not a copy) and a check for 1/2 value of the standard entry fee for the same event for which they received a waiver.

NOTE: Competitors may only use one (1) waiver per year for each discipline. Waivers must be used within the validity date located on each certificate. No extensions are granted on waivers.

Release & Liability Waivers:

All competitors are required to sign all release and liability waivers as a condition of entry.

****NEW FOR 2021**:** The photo release, W9 & liability waivers are on-line at www.americansmallbore.com to enable competitors to complete the forms **prior to arrival** for final registration at the range. This will further streamline the final registration process at the range and support COVID-19 protocols.

Competitors that refuse to agree with and provide and/or sign the release and liability waivers upon check in at the Stat Office will be denied entry and will NOT receive a refund of match registration fees.

Range Capacity:

- 170 competitors for 3-position phase
- 170 competitors for prone & F-SBR phase

**In the event that range capacity is reached for any phase, the ASSA may elect to modify the match program and/or firing times to accommodate the maximum number of competitors for the championships.*

Range Shelter:

The firing line consists of covered firing points. Competitors are encouraged to bring additional portable shelters to be set up behind the ready line in the event of inclement weather.

The area surrounding the range is prone to have heavy rain storms during the summer months. Competitors are reminded to bring appropriate rain gear. Umbrellas are not to be used when advancing down range to change targets.

Squadding:

Initial squadding for the first day of competition for each event will be at the match directors discretion.

After each day of competition, competitors will be squadded based on the overall running aggregate score for each discipline. Squadding will be conducted with the leading competitor located on the designated "center" firing point, with subsequent competitors alternating to the left and right outward based on their current overall aggregate score.

New daily squadding lists will be posted on the range bulletin board for competitors to verify their new firing point each morning.

If you are bringing a junior team and would like to request squadding in close proximity, please mail all entries in together or have all entries submitted online and send one (1) email with a list of names for consideration. Additional names cannot be added after the initial squadding request. Requested squadding cannot be guaranteed.

F-SBR competitors will be squadded together and integrated with the prone competitors. This squadding will also be conducted from the center of the range outward with at least one (1) prone competitor separating each of the F-SBR competitors.

Squadding for team events will be conducted at the range upon receipt of all team entries.

Cancellations / Refunds:

All requests for cancellation must be submitted in writing to ASSA at least thirty (30) days prior to the start of the first day of the competitor's scheduled competition. A \$30 cancellation fee will be applied to the refund in addition to credit card service fees (if entry was conducted on-line). All refunds will be a check sent via the US Postal Service.

Refunds will not be provided for cancellations received less than thirty (30) days prior to the start of the competition. Partial refunds will not be issued for any matches or phases not completed. Entry fees will be adjusted for partial cancellations requested for discounted packaged entries.

No refunds will be made to competitors due to disqualifications and/or expulsion due to safety or rule violations during the match(s).

Prone & 3-Position Any-Any Sight Entries:

Competitors age 55 and older may enter and elect to use any sights (i.e. scopes) for the entire prone and / or 3-position championships. For the Prone/Position ANY-ANY award category, a minimum of two (2) shooters are required for an award. Less than five (5) competitors will result in the award structure being pro-rated based on participation in that category.

Competitor Age Categories:

- Senior: starting 01 January of the calendar year of their 60th birthday
- Intermediate Senior: starting 01 January of the calendar year of their 55th birthday
- Junior: from 01 January of their 18th birthday through December 31 of the calendar year of their 20th birthday
- Intermediate Junior: from 01 January of their 15th birthday through 31 December of the calendar year of their 17th birthday (age 15-17)
- Sub-Junior: through 31 December of the calendar year of their 14th birthday (through age 14)

Team Entries:

For 2021, team entries and payment can be submitted via the on-line entry portal. Actual competitors that will constitute the team will be finalized at the range.

Team entries and payment can also be submitted at the range, however they will only be accepted up to range capacity (after squadding of on-line team entries) and are on a first-come, first-served basis. Team entry fees paid at the range must be either cash or check.

Team Types & Member Eligibility:

The following are the of types of teams that can register for the national championships as defined per ASSA rule book Section 4.6.4:

- Open
- Open Club

- Local Club
- State Association
- Service
- Collegiate
- Junior Local Club

Please note the following details associated with certain teams listed above in order to ensure proper registration.

- Open or “Pick Up Teams”, defined as “comprised of members who have no club or other organization as a central affiliation” are allowed. Open “Pick Up” teams are only eligible for Metallic Sight, Any Sight and Grand Aggregate Awards. Open “Pick Up” teams comprised of junior competitors are not eligible for any Junior Team awards. Open “Pick Up” teams are not eligible for setting national records.
- Open Club teams are defined as “members that belong to the same affiliated organization and are not restricted by geographic location.” (i.e. Blackhawks, Stinknicks, Eastern Beavers, etc)

In all instances, all team members must comply with all age and/or eligibility requirements. Failure to provide suitable proof upon request will result in the team being disqualified.

Coaching:

Coaching on the firing line is allowed ONLY DURING TEAM MATCHES per ASSA rules.

Competitors during the individual phases of the national matches can ONLY be coached after leaving the firing point and meeting their coach BEHIND the ready line. Hand signals and/or electronic communications are expressly forbidden and can be grounds for disqualification.

Lodging:

There are multiple hotels in the area surrounding Elkhart, IN.

ASSA has negotiated a reduced rate and reserved a limited block of rooms with Candlewood Suites in Elkhart. A special link for reservations is as follows:

- Cutoff date is [6/17/2021](#). After this date, reservations will be accepted on a space and rate available basis.
- Individual reservations can be canceled and/or modified up to 24 hours prior to date of arrival by 3:00 PM local time without penalty. Any cancellations/modifications after this date/time or reservations that result in a NO SHOW will be charged one night’s room and tax.
- Check in time is 3pm and check out time is 11am. Early check in is determined on day of arrival and is not guaranteed.
- For Call-In RESERVATIONS, please call 574-262-8600 and reference group code ASB OR use your link provided above.

Remember to book you hotel early. The surrounding area hosts many events and the closest hotels may have limited availability.

Camping:

Camping is available at the range.

No water or dumping is allowed on site. There are approximately 20 functional electrical hookups. Estimated charges are \$20 per night on a first come first serve basis, payable directly to the Chief Wa-Ke-De Range. Please contact ASSA for details on reservations, payment and any additional questions.

Entry Fees:

Entry fees for individuals and teams are to be submitted at time of registration.

Team entries for 3-position, F-Class and conventional prone can also be conducted on-line, but will also be accepted on site, with fees (cash or check) collected at that time. Team entries are accepted in the order they are received up to range capacity.

Team entry fees are \$45 per team for each phase (i.e. metallic sight phase, etc.). Note: Teams entering the championships that did not also shoot the individual portion will have a surcharge of \$40 applied per phase.

If you are entering both prone and position events, **DO NOT** enter both individual events. ASSA offers a discounted match package for both adult and junior competitors, highlighted in blue text below.

Rules:

The championship matches will be governed by the current ASSA Smallbore Rifle Rules, which can found at www.americansmallbore.com. Competitors are to familiarize themselves with information located in the match program and the current rules.

Failure of a competitor to follow the rules and match directives may be subject to disqualifications and/or expulsion from the range. Safety violations can be cause for disqualification and/or expulsion from the range . Competitors that are disqualified and/or expelled from the range due to safety violations will receive no refunds for entry fees.

Official Range Time:

The official range time will be kept by the Match Director. **Commence fire will occur at 8:45 AM each day.**

Equipment must be set up on the firing line by the completion of the preparation period for their relay to prevent disturbing fellow competitors. After no more than two (2) warnings, competitors who delay and/or are disturbing other shooters may be removed from range for that match stage by the Range Officer and will receive a DNF or ZERO score.

Official Bulletin:

There will be an official bulletin board located at the range. Shooters should be familiar with the location of the official bulletin board to check frequently for any posted Match Bulletins or Directives.

Scores will be posted on the official bulletin board, along with squadding information.

Target Changes:

Competitors will handle and hang their own unfired targets and pull down their own fired targets. Disabled shooters will be assisted by Range Personnel. Competitors are to furnish their own clips to hang targets and backers.

Target Identification:

Competitors are responsible for properly identifying their targets AND backers (including competitor number, match

number, match stage firing point and relay number (if multiple relays are used). Backers are to be marked in the upper right corner when positioned on the target frame.

Targets that are not able to be readily identified WILL NOT BE SCORED. It is then the competitor's responsibility to identify their target(s) within the allotted challenge period to have the target scored and score officially posted. If the competitor does not identify their target to be scored within the challenge period, a DNF or ZERO score will be posted.

Scoring:

The scoring of all targets will be conducted by match operations personnel. No competitor is allowed to use any type of scoring gage on a target at any time - including targets that have been officially scored and are located in the target viewing area.

Challenges:

Challenges must be submitted to the Statistical Office within the posted challenge period of the specific match score in question. Challenge fees will be \$3 for a competitor's individual score and \$5 for the challenge of another competitor's score. Challenge fees will be returned to the competitor if there is any numerical score change that requires a reposting of score(s).

Team score challenge fees shall be \$3 for a competitor's own team and \$5 for the challenge to another team's score.

Challenge Period:

The official challenge period for each match shall be posted by the Statistical Office. The challenge period shall be a minimum of two (2) hours after scores are posted for any match. Once the challenge period has ended, scores are final.

It is the competitor's responsibility to check their scores frequently for accuracy (both numerical score and x-count).

Official Match Jury (Scoring):

In the event that a competitor disagrees with the results of a challenged score, they may request to have the result reviewed by the match jury. For target challenges, the three (3) jury members will consist of personnel who did not score the challenged stage. The jury members will review the challenged stage and the majority decision will be final.

Protests:

Any protests to be lodged during the ASSA Championships must be completed and formally presented in writing to the Match Director on the same day of the occurrence of the grievance. The decision issued by ASSA on a protest is final.

Cash Awards & Tax Compliance:

Per current tax law, ASSA is required to notify the IRS of any tax event that occurs. (*A "tax event" is defined as a situation when a competitor - regardless of age - wins a minimum amount of \$600 in cash and/or merchandise at a competition. Plaques, medals and trophies are not included in the \$600 value.*)

To ensure compliance, ASSA requires each competitor to complete a W9 form. Since there is no way to predict which, if any, competitor will meet the tax event threshold, completion of the W9 is a mandatory requirement for all entries.

Every calendar year, ASSA issues a 1099-MISC to all competitors who win at least \$600 USD in cash and merchandise. The 1099-MISC form is sent via USPS first class mail to the competitor's address provided during the entry process. Copies of the 1099-MISC are also submitted per law to the IRS and each competitor's listed state of residence.

Awards:

Awards will consist of trophy plaques, medals, cash and donated merchandise as outlined below by match type. Cash prizes for each championship phase are determined based on the number of entries and any additional donated funds.

Awards (including major aggregate and special category awards) will be given if there are 5 or more competitors in a class. If there are less than five (5) competitors, they may be combined into the next higher class or the cash awards prorated at the discretion of ASSA.

For National Championship level competitions, any Unclassified entries will fire in the MASTER classification.

For the Prone and 3-Position ANY-ANY category, a minimum of two (2) shooters are required for an award. Any-Any competitors are not eligible for any metallic sight individual or aggregate match awards or the overall national championship awards.

For the Junior Championship award, any junior, regardless of age is eligible to with the Junior Champion award. (i.e. an Intermediate-Junior or Sub-Junior can with the overall Junior Champion award.)

The F-SBR Championship will have its own cash award pool based on entries and match sponsor donations. A trophy will be awarded to the overall ASSA Smallbore F-Class National Champion. Separate Open and T/R overall champion awards will be recognized if there are at least five (5) competitors in both divisions. Additional championship awards may be available from official match sponsors.

ASSA reserves the right to modify any portion of the awards program.

National Championship Awards:

Top three (3) overall competitors for each phase of the national championships are eligible for only one (1) additional special category award that will be selected and distributed per the following list (per competitor eligibility in descending order):

Special Category Awards:

- Civilian
- Service
- Woman
- Senior
- Intermediate-Senior
- Collegiate
- Junior
- Intermediate Junior
- Sub-Junior

The top three (3) overall competitors are not eligible for aggregate classification awards.

Competitors finishing outside of the top three (3) positions are eligible for a maximum of two (2) Special Category Awards.

Sponsors reserve the right to provide direction to ASSA on how donated cash and/or merchandise is awarded.

Metallic & Any-Sight Aggregate Awards:

Metallic & Any-Sight Championship aggregate awards apply to the Prone and 3-Position phases and consist of plaques, cash and supplier donated cash and/or merchandise.

Daily Aggregate Match Awards:

Daily aggregate match awards apply to the Prone and F-SBR phases and will consist of cash.

Individual Match Awards:

Individual match awards will consist of cash distributed for each discipline based on the number of entries for each classification. No special category awards (i.e. Civilian, Junior, etc.) are distributed for individual matches. ASSA reserves the right to pro-rate cash awards and/or combine classifications.

Team Awards:

The number of overall, class and special category awards will be based on the number of entries.

Award Distributions:

Donated specific monetary awards will be provided to the winners during the official phase award ceremony. All other monetary awards (i.e. individual match awards) will be via checks mailed via the USPA after the completion of the national championships. Monetary awards will be mailed to the address provided during the entry process.

Trophies, plaques, medallions and donated merchandise is awarded during each official phase award ceremony. ASSA will not mail any of these awards if the winner is not present. In the event a winner of such awards cannot be present at the ceremony, it is their responsibility to arrange for pick up and delivery via another person (at no risk to ASSA).

Practice Sessions:

The practice session for 3-position will start at 1pm on July 2, 2021 and end at approximately 3pm.

The practice session for F-SBR and prone will start approximately 30 minutes after the completion of the 3-position team matches on July 5, 2021. This practice session may be temporarily suspended for the 3-position team awards ceremony.

During the above practice sessions, ASSA is working with our match sponsors to conduct additional matches such as a Mentor Match, etc. Additional information will be released as details are finalized, which may require adjustment to the durations of the practice sessions.

For USPS "paper" Entries

Include a copy of the ASSA Regional Waiver award with your forms and a check for 1/2 of the regular entry fee (for the discipline of your waiver). Failure to include a copy of the waiver will result in no entry fee reduction until the waiver is presented to ASSA.
